- STARTED IN 2002
- TWO GRANTS THAT FUND THE PROGRAM: FIRST 5 AND COLLABORATIVE JUSTICE: SUBSTANCE ABUSE FOCUS GRANT
- COURT LEADERSHIP: JUDICIAL AND ADMINISTRATION SUPPORT – PRESIDING JUDGE, FAMILY SUPERVISING JUDGE, CEO, FAMILY COURT SERVICES

FLTC: Mission Statement

Through judicial oversight and enhanced access to comprehensive treatment services, the Family Law Treatment Court (FLTC) supports parents in their recovery. FLTC improves the safety and welfare of children by supporting a parent's recovery from substance abuse and connecting parents with co-occurring mental health issues to services.

What is Family Law Treatment Court (FLTC)?

- FLTC is a voluntary, 1 year court-supervised drug and alcohol treatment monitoring program for parents with children involved in custody hearings in Family Court.
- The purpose of FLTC, the Judge and Special Resource Program Specialists is to improve the safety and welfare of children by supporting parents in their recovery from substance abuse. Follow well-established treatment court models. A parent in FLTC will be connected to a variety of services, including recovery treatment programs and, if needed, mental health services.
- Although not guaranteed, the goal for a parent who participates and/or graduates from the program is to have improved access to their child(ren).

FLTC: Goals

Goal #1

 Assist participants in recovery from substance abuse and cooccurring mental health issues to make positive changes in their lives and children's lives

• Assist participants through process of change to improve their wellbeing and strive to reach their full potential as parents

 Assist participants to reach their full potential as parents by connecting their children to early screening and treatment services

Who Is the Program For?

- INDIVIDUALS WHO ADMIT TO HAVING HAD OR CURRENTLY HAVE A SUBSTANCE ABUSE PROBLEM.

 GUARDIANSHIP CASE IN SANTA CLARA COUNTY

Family Law Treatment Court Requirements

Enter and complete an inpatient/ outpatient program Attend a minimum of 3 AA/NA or 12 step alternative meetings a week Find a sponsor and work the 12 steps (if applicable to your program) Participate weekly or twice weekly random drug/alcohol tests at FLTC approved site Attend FLTC hearings on time

Intake with Resource Specialist

- Intake and waiver forms completed
- History of substance abuse discussed
- Referred to outpatient, inpatient, or relapse prevention programs (clients walked to SUTS for an appointment/assessment)
- Referred to FIRST 5 and other community resources
- Testing Fees and other testing sources such as SOBERLINK, BACtrack, and SCRAM

Test Results and Notices

- NOTIFICATION WILL BE SENT TO THE OPPOSING PARTY AND ALL ATTORNEYS INVOLVED IN THE CASE FOR ALL MISSED, DILUTE AND POSITIVE TESTS, SUSPENSION, TERMINATION OR VOLUNTARY WITHDRAWAL FROM THE PROGRAM.
- IF CLIENT HAS <u>UNSUPERVISED</u> ACCESS TO THEIR CHILD(REN) AND HAVE A MISSED, POSITIVE OR DILUTE, AN EMERGENCY REVIEW HEARING WILL BE SCHEDULED IMMEDIATELY WITH YOUR APJ.

Review Hearings

The FLTC parent is entitled to a review with their All-Purpose Judge every 120 days. These hearings are specially set only by the FLTC Resource Specialists. Notices go out and all parties as well as attorney's are required to attend those hearing since custody changes may occur.

The FLTC Resource Specialists will provide the APJ with a progress report that includes testing results, information on program compliance and what programs the client is currently enrolled in/has completed. The opposing party, attorneys, including minor's counsel, and Judge will be provided with a copy.

Graduated Sanctions

Missed/Dilute/Positive Tests or suspension/term/withdrawal = Notice to other party and attorneys

Missed/Dilute/Positive test + unsupervised contact = Emergency review hearing

Non-compliance = up to suspension/termination
 Increased FLTC Appearances
